Consent Agenda; - Minutes of previous meeting, land splits, payment of bills (\$70,015.10) permits. PUBLIC HEARING MEDICAL MARIHUANA ORDINANCE review. Opened at 7:11pm-Dissussion Methner commented that we have had several inquires as to what we had available, and the fact that some were from current growers wanting to increase. Suggested that we increase the 1500 Class C, Processors, if you grow you might want to do your processing, and maybe Provisioning Center. Moved by Methner to increase as follows: Class C 1500 grows, increase but limit will be at the Township Boards discretion, Processors, increase but limit will be at the Township Boards discretion, Provisioning Center increase by 1, leave all others the same. Supported by Card.

Reports: Library-working with the City of Clare on the Unemployment and MERS Retirement cost. There is some talk to try to make changes. Cost could be cheaper. Fire- Coleman got a new pickup, worked on the ordinance for fire charging fees on some runs. Roads- work has all been done, the light is working at Leaton & Pere Marquette. Cemetery roads are being done now; they look good.
